EGH provides a welcoming and respectful refuge where women who experience homelessness, economic insecurity, or trauma have access to a caring community and critical resources. Women visit our drop-in Day Center to receive support, services to meet basic needs (food, clothing, showers, laundry, mail service, personal care items, device charging, bus tickets), warm referrals, and case management. In 2022, our Day Center served 436 women for a total of 7,290 visits and provided 10,615 meals.

EGH's Transitional House affords eight single, adult women experiencing homelessness a place to live for up to two years. This environment prepares women to be self-sustaining, independent, and have safe lives. EGH aspires to ensure that 100 percent of the women who leave the transitional house for permanent housing will never be homeless again. In order to achieve this goal, EGH offers help in four critical areas: attaining permanent housing, building financial stability, maintaining social connections, and developing interpersonal skills. In addition to educational opportunities, residents also gain essential practical experience through volunteering or employment opportunities.

Clients self-declare their need and may seek food or personal care items weekly. We do not provide monetary funding to our Day Center clients, we provide assistance in the form of bus tickets, donated gift cards, donated clothing and hygiene items, food, meals, and assist with the fees to get an ID or drivers' license and food handlers permits. When our residents exit our Transitional Housing program, we provide a 5% match on the money they save while they are in the program. We have an outside funder, the University Presbyterian Church Deacon Fund that reimburses us for other client expenses that they approve.
